Rules for Freeship or Scholarship and documents to be attached

- Parents / Guardian should note that if freeship or scholarship form is not submitted in time, then the entire fees for the full year needs to be paid.
- Those who get admission under a reserved category are mandatorily required to fill the online form for freeship and scholarship. The time period for filling the form will be intimated on the website of Maharashtra Government. Forms received after the due date shall not be accepted. Attendance of each student should be minimum 75%.
- All instructions should be followed while filling the online form. If the student fills wrong
 information, then the risk of losing of freeship and scholarship or getting lesser amount from
 the Government shall be of the student only. In case of gap in academics of a student, the
 student who has received scholarship in earlier year shall not get the scholarship again. In
 such a case, the student has to pay the full fees.
- In case of change in rules of the Government with respect to freeship or scholarship, the enter liability shall be of the student himself / herself. Giving of freeship and scholarship is the sole discretion of the Government.
- Once the application is accepted by the Department, the fees depicted on the website in the Redeem section shall be held as the final fees. The pending fees, after deduction of fees paid from the expected fees, shall be paid by the student.
- Once the form is accepted by the college, the student should regularly login and check the Remarks section. If the Government suggests any changes, then the student shall take necessary action in this regard and also intimate the college about it. The responsibility of the form is solely of the student. If changes are suggested by the Government and such changes are not made within the stipulated time period and the application is auto rejected, then the entire fees has to be paid by the student.
