

Good day everyone today we have with you Smt. Chandana Chakraborti who is the Vice Principal of M. L. Dahanukar college. First of all we welcome you ma'am to this interview and now without further ado we'll start with the interview.

1. Ma'am, you are the vice principal of M. L Dahanukar College of Commerce so what struggles Did you face to reach where you are now?

- Yes. Well struggles as such, I didn't face any big types of a struggle but then definitely being a woman, there were lots of frontiers that we have to face, that I had to face during my early years like managing the house, managing the family and management of our job at the same time, but I really did not have to face much struggle to become the vice principal of this college. Long hard work yes, which had to be put in, a lot of committees, lots of portfolios that have to be managed but then ultimately, I think your hard work pays off so nothing as such basically to mention about any type of struggle that I had.

2. Ma'am "EARN WITH LEARN" is a new concept which is gaining quite ground in the youngsters nowadays. How do you support this idea or do you support this idea of "Learning with Earning"?

- Yes, this is one of the primary aim of education. Education is basically meant to prepare you for life, so that you can earn a livelihood and you can lead a decent life when you grow to maturity. Now, this is not something which is very new concept. It is a concept, which is very old, and one of the goals of education but in India, this concept of Earn while you Learn is less popular now in recent times and yes, it's definitely a very good idea. Because today's education is not very cheap. There are various types of courses, which are very, very expensive because of privatization and when the student is earning fees he's able to support as he or she is able to support his own education and this is definitely a very good idea. It builds a sense of responsibility in the mind of the student. The student takes the course more seriously because the desire and the earning is there to learn, because you're putting in your hard earned money in it. So, there is a lot of difference that will come in the outcome of learning also.

Nowadays, students are faced with the weariness of "ONLINE LEARNING". So, what measures do you think can enhance this online system?

- Now, out of compulsion, we have entered into an era where we are having 100% online lectures. This is a via media which was chosen during this COVID period so that students don't suffer and there is no break in education because actually a matter of necessity. There are lots of good points also of online learning but what I feel from a student's viewpoint is that when you are constantly on online mode, capturing, as a teacher also, capturing the interest of the students becomes a little difficult. Now, there are many ways in which students can be motivated to perform better, to listen, to be more attentive to the lecture.



For example, if we have more quizzes involved more some games which are there, which are educational games, educational videos, which can be played instead of having a lecture of 60 minutes constantly where the teacher is continuously speaking and the student is just a passive listener at the other end. It can become boring, monotonous, and after some time the student loses interest. So, there has to be some variety in teaching you cannot have 100% lecture method, you have to opt for some other type of methods of teaching as well. So having constant quizzes having some types of maybe, involving the students in teaching like "Flip Teaching" in which students will be given some topic and ask them to now tell me, "How do you teach this topic. Such type of things can definitely create an interest in the minds of the students and at least some students will get benefited from this type if we bring some variation in our teaching method.

- 4. Now that the H.S.C results are declared. There's a whole lot of debate going on how they manage to pass even without exams. So what is your opinion on this so called "COVID batch?"
- Now Yeah, this is a very interesting question. But I would like to little bit correct you because COVID batch, it's not only the HSC students, but I think SSC First Year Junior College, HSC, everybody is a COVID batch. Yeah, this is very unfortunate that these students, because to me, H.S.C is a very crucial year for students because there are lots of other options which are opening up after on the basis of their performance. So it's a year, when the parents are very worried, students are worried, they put in a lot of hard work trying to get and crack different exams. Now, this year, as there has been no exams as such, to test the capability of the students, maybe we can say is that some people might be of opinion that they know the actual learning has not happened but then the students who are actually learning from the beginning of the year till the last minute, they didn't know that there will be no exams. So I'm sure the students have been preparing and studying on their own, trying to prepare themselves for an exam because nothing was clear till the end. So, I guess the students have definitely done some amount of studying but we have not been able to assess their performances. But yes, but this COVID batch is definitely you can say it could be a bonanza for some students, but it can be some demerits for some very good students who actually are hard workers. You have to take it with a "pinch of salt", this COVID batch is definitely something that shouldn't have happened.
- 5. Now Mumbai University now conducts exam online due to the COVID crisis. Now, in case of a scenario where the crisis met its end, will you still be willing to conduct the exam in an online mode, as it is boosting of factors to distance learning?
- Once this crisis is under control, maybe we can have this mode of assessment even in the future but it cannot be 100%. Partially it can be Yes, but not definitely not 100%. Like we have done for the last one and a half years. I, as being on the other side, being on the administrative side, I will tell you that it is very difficult to judge students properly. We all are aware that there is a bonanza of marks that students are scoring. We have cases where students have not been able to perform well in some subjects and with the online mode of examinations, they have managed to get very good marks. So, you know as I told earlier also there is no parameter to separate out the good studious students, intelligence students from the average or below average students if we go in with this online mode 100% but definitely online mode also should not be discarded because it is as you have rightly said, it is good for distance learning, as well as there are the students can from anywhere assess and give the examinations but 100% No, I wouldn't recommend it. Maybe 10 out of 100 maybe 10, 20% assessment can be fallen online, more but 80% has to be on offline mode, according to me, or else it becomes difficult to judge a student's performance.

6. What message would you give to the teachers coping with the online mode?

- Yes, it's been a huge learning experience for me as well, because we have worked for more than 25 years, I've been practicing a particular type of teaching and then suddenly, one day, I am told to go and teach in online mode, wherein I didn't even know how to open up a Google Classroom or how to share my screen. So a huge learning experience, in which I'm sure all teachers will agree with me that we have also learned a lot. It has been an eye opener for all teachers and what we were unwilling to accept somewhere or the other there was a inertia on our teaching communities, on the part of the teaching community to move over to online mode. In fact, UGC, our apex body has been strongly recommending for more than 10 years to have some type of virtual teaching but this inertia was not, we are not coming out of it. But this COVID has made us sit up and out of compulsion, we have learned how to deal with online mode of teaching. On behalf of all the teachers, I'll tell you, it has not been very easy for us. But at the same time, I think, given the times and circumstances, it was the only way in which we could deal with the classroom teaching. So teachers have definitely learned a lot and we are teachers will have to continue with online teaching. We should not just discard it off once the offline mode starts. Because very often, it is not possible for all students to come and in the near future, also, the problem is not going to just disappear, it's going to be there for quite some time, so we have to continue with it. What we have to continue with, we have to make it the entire learning process, even the teachers, for them, it's a learning process, we have to make it as joyful as possible that this is what we have to do. Therefore let us try and do the best we can, learn new technologies, learn new methods, and that is what entire process of teaching and learning is about.

7. What message would you give to the students through "The Students Press?

- Yes, to my very dear students, I would definitely like to convey this message on my part, as a teacher, the problem that I have experienced is it is extremely, extremely frustrating and students are physically present in the classroom, you can see that number of students are there in the classroom, but there's simply no response from the students. Also, we don't know whether the students are listening to you or not, that becomes extremely, you know, disheartening for the teachers, I would like to request the students that "Be a little bit more proactive in the classroom, I know it is not so easy when you're sitting in the comfort of your home, probably in our environment, sometimes which is too comfortable, or sometimes which may be too harsh. So, you know, in the home environment, that particular classroom type situation is not there. So there are a lot of disturbances that are around you, a lot of distractions, disturbances around you. So very often you just switch on into the classroom, but you're busy doing something else. So I would like to request to the students that "See, this is the present mode of teaching and learning and you're losing out on important years of your life if you don't learn anything from the classroom from the online mode of teaching. It's not always how much marks you score that matters, what matters that what you have learned. At the end of the day, that is what is most important. You might have scored 90%, 95% but when you are not able to give them the basic. You don't even have knowledge of the basic information, some basic concepts, then actually no learning has occurred. You have got good marks but no knowledge. Learning should be for knowledge and not for marks. This is the most important thing I think students should understand. Because ultimately, lifelong you this learning will help you out.

NSS - Lending a hand to the Flood Reliefs

M.L. Dahanukar College of Commerce, Mumbai along with its educational role has always lively involved in the socio-cultural activities to nurture the society. Both, the students as well the teachers contribute to achieve this objective. Particularly, National Service Scheme (NSS) unit of MLDC acts as the right hand for turning this point true. As on 24th July, 2021 heavy rains created havoc, flood devasted Mahad and nearby villages in Raigad district of Maharashtra which affected many lives there. So 'A Flood Relief Activity' was organized by NSS unit. The preparations for conducting this activity started on the same day. Respected teachers along with the ambitious students participated in this activity.

The student volunteers co- ordinated within themselves for performing various tasks like: appealing the people to give a hand for donation of relief material, collection of the relief material which are essential from donors, segregation, packaging of the same. Specifically 15 volunteers participated in segregating and packaging this relief material in a very spontaneous manner.

The collection of relief material for flood affected people included necessities like rice, pulses, sugar, edible oil and other food material, clothes, hygiene related things including toothpastes, toothbrushes, sanitary pads, diapers, etc. Collecting required materials was done by the volunteers on large scale and activity was quite a hit. The volunteers, through their immense effort able to prepare 135 kits of essentials containing almost 2.85 tons of relief material successfully.

It is said that "Help is not complete till it reaches the beneficiaries" .So on 3rd august,2021 8 junior volunteers, 5 ex-volunteers plus Program Officers, Mr. Samrat Gangurde and Mr. Shuddhodhan Athwale, personally visited 3 sites namely Karanjkhol, Mahad and Birwadi in Raigad, Maharashtra. There they distributed the relief material kits of essential commodities to the needy families. At the end, they returned home by making many faces smile. The programm was not a help rather it is a responsibility towards the society. As all know, it was not enough but it surely created a difference not only in society but also all participating.

INDIA'S OLYPMIC STARS BAGGED THEIR BEST PERFORMANCE

They say save the best for last and for India it came true at the Tokyo Games.

Javelin thrower Neeraj Chopra became only the second Indian to win an individual gold in the Olympics. After romanticising stories about "nearly there" for years, India finally had its first track-and-field medal winner, thanks to Chopra's throw of 87.58m. Interestingly, Chopra, the son of a farmer from Khandra village near Panipat in Haryana, took to athletics to lose weight.

The 23-year-old, a Subedar with 4 Rajputana Rifles in the Indian Army, has been a consistent performer since bursting into the scene with a historic gold in the junior world championships in 2016 with an Under-20 world record of 86.48m which still stands.

The pint-sized weightlifter from Manipuri lifted the spirits of the entire nation as she ended a 21-year wait for a medal in weightlifting, clinching a silver medal in the 49kg category to open India's account on the very first day of competitions on July 24. Wearing gold earrings shaped like the Olympic rings, which were a gift from her mother who sold her own jewellery for them five years ago, the 26-year-old lifted a total of 202kg (87kg+115kg), finally exorcising the ghosts of her disastrous outing in the 2016 Rio Games where she had failed to log a single legitimate lift.

Such was her dominance at the Tokyo Games that she dropped only two games, both in the semifinal loss to Tai Tzu Ying, in six matches. Abstract:

As the technological ecosystem is gearing itself to take up the challenge of accomplishing the various tasks in a novel manner, the humane resource is also upgrading and upskilling for the new working environment. The short- term scenario is a matter of situational management and able leadership to steer through the turbulence. However, in the long-term scenario, diverse entities are working towards repositioning themselves to draw from the fountainhead of technology and to execute tasks with efficiency, powered by meticulous planning. This requires infrastructure planning as well as enterprise resource planning to fill the technology gap and bridge the digital divide. Associated economic and financial handles also need to be considered and strategic planning needs to focus on practically achievable targets.

Literature Review:

The need for strategic business imperatives are playing a role in exploring the merger of business and technology strategies and reimagining technology's role in the business. Fundamental questions about the future of work need to be addressed by leveraging technology and redesigning work outcomes that extend beyond productivity and cost to value, meaning and impact. In an interview conducted in February 2019, Satish Alapati, CIO of Media & Entertainment Customer Experience at AT&T stated that because of technological advances, technology's role within the organisation is itself shifting. He further stated that technology has evolved from automating the business to actually being the business.

Artificial intelligence should be harnessed as a critical component of the post-covid world diaspora. Nations need to implement well conceptualised and reated AI systems to achieve objectives. Nisha Desai Biswal, the president of US India Business Council (USIBC) said India is expected to benefit as it is expected that businesses will want to de-risk in having too much of a supply chain concentrated in one area and try to diversify and disperse. Strategic planning must also take into account the volatility and uncertainty in the external environment.

Introduction:

The post-covid workplace scenario will necessarily need to realign itself to a new working paradigm. We need to reinvent the wheel with the changed perception of how tomorrow's workforce will be different, the changing roles and dimensions of operation, the required skills and capabilities and the continued growth and sustainability factors.

The work, workforce and workplace are metamorphosing and transforming in the background of the covid scenario. The post covid economic diaspora is still in its infancy and the uncertain future must necessarily ensure sustainable strategies. However, the lessons and the manner in which the situation was handled serves as the fundamental building block for effective strategies. Hypothesis:

Research Methodology:

The Research Methodology followed is exploratory with qualitative and quantitative analysis. The qualitative analysis is from reliable secondary data. Quantitative analysis from primary data has been gathered from a wide cross-section of people comprising entrepreneurs, academicians, corporates and think-tanks from across the world. Data has been analysed using the percentage method.

Findings:

Primary Data analysis:

The results of the primary data analysis revealed that over 90% of respondents replied in the affirmative to the following questions:

- i)Is strategising with respect to Artificial Intelligence essential to ensure global preparedness?
- ii) Are efficient Knowledge Management strategies the key to unlock future dividends with respect to overall global sustainability?

90% of the respondents replied in the negative to the following questions:

i)Will artificial intelligence strategies result in inability to effectively plan and deploy with respect to practical achievement of objectives?

ii)Will Knowledge Management strategies be cumbersome and unrealistic?

Secondary Data Analysis:

The merger of business and technology strategies and the reimagination of technology's role in the business is the way forward with respect to future preparedness for Nations as well as organisations. Artificial Intelligence must be leveraged to focus on exponential increases in productivity and cost efficiencies and to redefine new work outcomes. The workforce and the workplace will have to be redesigned to support constantly evolving technology.

Much in the same way that we started the decade in uncertainty, we appear to be headed back into a period of uncertainty. With the rest of the world, we watched in disbelief as the COVID-19 pandemic took hold at the beginning of 2020 and changed life as we knew it. In March, more than a third of humanity was in lockdown. By the end of April, 1.6 billion workers stood in immediate danger of having their livelihoods destroyed. As job losses escalate, nearly half of global workforce at risk of losing livelihoods.2

Recent data reveals that in a matter of around eight weeks we have transitioned to a new way of consumer and business digital adoption. Banks are working with remote sales and service teams, digital outreach enabling platforms have been launched for customers to make flexible payment arrangements for mortgages and loans, grocery stores have enabled online ordering and delivery modules, educational institutions have pivoted to present online learning and digital classrooms, tele-medicine has created new inroads in the health sector, manufacturing companies are realigning supply chains with technology; the list goes on.

Organisations will have to confront some structural challenges. The change in customer behaviours and preferred interactions must be taken note of and digital services aided by AI will have to be enabled. Secondly, people using the digital channels have expressed that they will continue using them when things return to normal. This will have to be maintained and strengthened with good interactive modules. Thirdly, in order to succeed in the new environment, companies will need to ensure that their digital channels are on par or better than those of their competitors.6

Conclusion:

The trends of future sustenance and growth in overall spheres will be based on technological prowess and Artificial Intelligence backed by Deep Learning systems. 

India's trade deficit China dips to USD 44 billion in 2020-21

India's trade deficit with China has declined from USD 53.57 billion in 2018-19 to USD 44.02 billion in 2020-21, Minister of State for Commerce and Industry Anupriya Patel stated the fact. Exports to China has increased to USD 21.19 billion in 2020-21 from USD 16.61 billion in 2019-20, Patel said in a written reply to the Rajya Sabha. Exports were USD 16.75 billion in 2018-19. Imports from China during 2018-19, 2019-20 and 2020-21 were worth USD 70.32 billion, USD 65.26 billion and USD 65.21 billion, respectively In a separate reply, she said the decline in India's export of automobiles, including cars, is largely due to global economic slowdown and supply chain disruptions due to Covid-19 pandemic. India's trade deficit with China narrowed last calendar year as exports rose 16.15% to \$20.25 billion, led by iron and steel, aluminium and copper, while imports shrunk 10.87% to \$66.78 billion.


The country's trade deficit with China fell to \$45.91 billion from \$56.95 billion in 2019, officials said. Shipments to China crossed \$20 billion for the first time even as exports of mangoes, fish oil, grapes and tea declined.

China was India's largest trade partner, according to India's official data for April-December FY21. In order to reduce its dependence on imports, especially for non-essential and low-quality goods particularly from China, India has launched production-linked incentive scheme to promote domestic manufacturing, mandated local content in public procurement, restricted and prohibited certain imports, put in place quality control orders, and launched a series of anti-dumping probes It has also tightened the scrutiny of imports that make their way through free trade agreement partners. Besides, 24 focus sectors have been identified in which the country is keen to become self-reliant.

As per the official, India is now the fourth largest exporter of iron ore, and iron and steel to China and the fifth largest exporter of aluminium and its products to China.

"The exports growth maybe healthy but most of our exports to China have been of primary goods and raw materials while imports have been largely intermediate and finished goods," said a Delhi-based trade expert. "The trade imbalance can't be corrected till this trend changes."

AFGHANISTAN TALIBAN CRISIS REACHED IT'S PEAK

"Afghanistan, not a collapse of city but a collapse of thousands of dreams, culture, history and people." statement given by resident of Afghanistan summed the whole chaotic situation in Afghanistan.

The whole collapse started on 15 of August when the Taliban declared victory after Afghan President Ashraf Ghani fled and his government collapsed.

The militants' return to rule brings an end to almost 20 years of a US-led coalition's presence in the country. Kabul was the last major city in Afghanistan to fall to a Taliban offensive that began in May of this years but accelerated in recent days as they gained control of territories, shocking many observers. This fall witnessed a great devastation of people's hope who are now desperate to make escape from the country.

Many thronged the runway, running alongside a moving military transporter aircraft as it prepared for take-off. A remarkable picture from Sunday appears to show 640 Afghans packed onboard a US military cargo plane leaving Kabul for Qatar. Panicked civilians had scrambled up the loading ramp but the crew decided it was best to take off rather than force the Afghans off.

Struggle was long for Afghans as riffle between Us and Taliban had it's roots rooted deep down. The United States invasion of Afghanistan occurred after the September 11 attacks in late 2001. Its public aims were to dismantle al-Qaeda and deny it a safe base of operations in Afghanistan by removing the Taliban from power. US President George W. Bush demanded that the Taliban hand over Osama bin Laden and expel al-Qaeda; bin Laden had already been wanted by the FBI since 1998. The US and its allies rapidly drove the Taliban from power by December 17, 2001, and built military bases near major cities across the country. Most al-Qaeda and Taliban members were not captured, escaping to neighboring Pakistan. India is supposedly to get affected by Taliban rule in Afghanistan. India was known to be a great helper to Afghani government to maintain democracy and law and order in the country. The Indian Government has not yet issued any statement to evacuate the Afghans but it has successfully evacuated Indian nationals and embassies on 15 of August.

The major issue facing by the Indian Government are bringing down the Indian Nationals. On Sunday, an Air India flight was able to fly out carrying 129 passengers from Kabul to Delhi. Another problem is to help the Afghans to leave the country. The strategic response is also equally important to this situation.

The Chinese Government in a statement said that they are willing to develop friendly relations with the Taliban thus supporting the Taliban government.

AFP reported. "China respects the right of the Afghan people to independently determine their own destiny and is willing to continue to develop... friendly and cooperative relations with Afghanistan," foreign ministry spokeswoman Hua Chunying said, as per AFP.

The 2020 Summer Olympics is an multi national sports event commenced on 23 of August with some preliminary events starting on 21 of July in Tokyo ,Japan

Tokyo was selected as the host city to conduct the Mega sports event. Originally scheduled to take place from 24 July to 9 August 2020, the event was postponed to 2021 in March 2020 as a result of the COVID-19 pandemic, the first such instance in the history of the Olympic Games. It was largely held behind closed doors with no public spectators permitted due to the declaration of a state of emergency in the Greater Tokyo Area in response to the pandemic.

The United States topped the medal count by both total golds (39) and total medals (113), with China finishing second by both respects (38 and 88). Host nation Japan finished third, setting a record for the most gold medals and total medals ever won by their delegation at an Olympic Games with 27 and 58. Great Britain finished fourth, with a total of 22 gold and 65 medals, becoming the first nation at the Summer Olympics to increase or equal their total medals won in the two Games subsequent to hosting them. The Russian delegation competing as the ROC finished fifth with 20 gold medals and third in the overall medal count, with 71 medals. Bermuda, the Philippines and Qatar won their first-ever Olympic gold medals. Burkina Faso, San Marino and Turkmenistan won their first-ever Olympic medals. India ranked 48 in the overall medal count by a country.

The event hold something different for India. What was not happened in the history of India was destined to be happen this year. The first medal in athletic event was bagged by India this year. The credit goes to new sensation Neeraj Chopra who bagged the highest honor by winning the Gold medal in Javellion throw. Neeraj Chopra dedicated this medal to late Milkha Singh Ji was always dreamt to win a gold medal for India and a gold medal is the greatest tribute one can give to him. The moment would be held in great esteem by Indians to cherish in coming years. India also progressed as a country by producing quality players and also by medal count.

This fort was the Naval headquarters of the Marathas. Chhatrapati Shivaji Maharaj built this fort to safeguard the marine border from the northern rule it took three years along with 100 Portuguese architects and 3000 work force. One can travel by boat to the fort then entering through the Dilli Darwaja also known as the main gate because to the clever architecture the Darwaja is only visible when one goes close to the forts otherwise seeming a part of the walls. Apart from the fort one can also visit the Tarkarli Beach known for its water sports activities and taste the amazing Malvani cuisine.
